XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at Hackberry 34 CTB (NRM2010853797). The release was discovered on April 2, 2020 and delineation activities have been completed. Remedial activities were initiated but were temporarily suspended to review and address remediation efforts via excavation in an area of significant above- and below-ground utilities. In order to complete the remediation work safely and submit a remediation work plan or closure report, XTO requests a 90-day extension of this deadline until September 29, 2020.
