Remediation work is delayed due to heavy traffic immediately adjacent to the release extent, requiring additional safety precautions and occasionally delaying work to weekends only. A review of our most recent laboratory analytical results indicates additional work is needed at this Site in order to prepare a remediation work plan or closure report.
