XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the PLU PB 25-25-30 USA 001 Battery (Incident Number NRM2012953444). The release was discovered April 25, 2020. Remediation activities are currently ongoing, and the most recent laboratory analytical results indicate further remediation work is warranted. In order to complete the remediation work and submit a remediation work plan or closure report XTO requests a 60 day extension of this deadline until September 24, 2020.
