All,

We had a release at the Hayduke 34 Federal 1H last night. The 2" ball valve right before the water transfer pump washed out from the inside due to corrosion, spilling 32 bbls of produced water in the gravel lined containment. We recovered 30 barrels of produced water and the valve has been replaced. We will remove gravel to inspect the liner, make sure the liner is intact and request an inspection from the NMOCD and BLM before replacing the gravel.
