All,

XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the ADU Hondo Tester (NVV2003542379). The release was discovered January 5, 2020 and initial site assessment was completed January 29, 2020. Released fluids flowed onto the pad and into the surrounding pasture. A Right of Entry (ROE) Permit was submitted to the State Land Office (SLO) on March 3, 2020. The executed permit was received May 11, 2020. XTO began remediation activities at the site including excavation of impacted soils. To

date approximately 590 cubic yards of impacted soil have been removed. The most recent laboratory results indicate additional remediation work is warranted. In order to conduct the remaining remediation work and draft a closure report or remediation work plan, XTO is requesting a 90 day extension of the deadline to January 4, 2020.
