- 1) MI & RU CU. Kill well. ND WH. NU BOP.
- 2) Rel pkr. POH w/tbg & pkr.
- 3) PU & RIH w/RBP for 5" csg. Set RBP @ 8810'. Raise EOT to 8772'.
- 4) Spot 250 gal 7-1/2% acid. POH. RIH w/pkr assem. Set pkr @ 7170'.
- 5) Press test to 1000 psi. Swab.
- 6) Perf 8726-32'; 8736-47'; 8756-60'; 8766-72' w/4 JSPF. POH.
- 7) Load tbg. BD perfs. Displace acid. Swab.
- 8) A w/2500 gal 7-1/2% Morrow Sand Acid. Swab.
- 9) F w/889 bbls binary foam w/50000# 20/40 interprop. Flow test.
- 10) Flow test until CO₂ & nitrogen are below inert limits.
- 11) Place well on production
