Dear Ms. Carlisle:

We received your FAX of March 8. In lieu of the relinquishment executed by Siete attached to that FAX, it would seem that J.C. Williamson should be allowed to assume operations without requiring anything further from Siete or its successors. I would suggest that simultaneous Change of Operator forms be file, changing this well from Siete to J.C. Williamson and from Williamson to SMLE. A copy of Siete's disclaimer should be attached.

J. C. Williamson (Williamson) originally permitted the captioned well in July 1988. This permit was approved by the BLM in October 1988. The well spudded October 24, 1988, but encountered hole problems at 2567 feet. Williamson was unable to drill deeper.

In July of 1990 Siete Oil & Gas Corporation (Siete) took over as operator of the well and used it as a water source well for drilling purposes. Siete remains operator of record since that time.

Effective January 1, 1996, St. Mary Land & Exploration Company (SMLE) purchased most, but not all, of the properties owned by Siete. However, the EXX Federal 1 was not included on the Assignment and Bill of Sale into SMLE. Sometime after SMLE's purchase of many of Siete's assets, Siete was dissolved. That corporation is now defunct.

In July 1997 SMLE acquired the right to use the well from J.C. Williamson as a water source well. The BLM has also recognized J.C. Williamson as the current operator and recently notified this company with regard to certain routine maintenance matters that required attention. J.C. Williamson acted to correct these items as though it were operator of record.

SMLE has now approached J.C. Williamson to purchase this wellbore, and an Assignment and Bill of Sale has been drawn up effective March 1, 2004 for SMLE to purchase this wellbore and take over as operator of the well. While attempting to prepare the Change of Operator form, the OCD advised that Siete is still operator of record.

Please advise what action needs to be taken to correct the records so that SMLE can take over operations of this well.

We appreciate your assistance in clarifying this situation.

We are in receipt of your letter of February 20 regarding the referenced well.

In order to address this request, we will need some additional information. As stated in your letter, it would seem that Williamson transferred this well to Siete Oil & Gas, which was subsequently dissolved. It does not explain how ownership of the well reverted back to J.C. Williamson, instead of to Siete's stockholders or creditors. We will need an explanation of the source of Williamson's ownership before we can proceed further in this matter.
