Marathon Oil Co. intends to deepen this well to the Morrow. Deepening operations will require construction of reserve pit. Marathon request constructing a 50' X 50'(2,500sq. ft.) reserve pit at the site of the original approved reserve pit. No new disturbance area. Cuttings removed from original pit during construction will be stockpiled on a liner to prevent surface contamination. Pit will be padded to accept a 12 Mil liner. At the end of drilling operations pit area will be reclaimed as per BLM's requirements.
