4/01/04 Installed 5 1/2 lift sub on casing, rigged up wire line, backed off 5 1/2 csg 2 joints down, ran 2 new joints 5 1/2 and screwed into casing, loaded csg with treated water and pressured to 520 psi, held 520 psi for 30 min on pressure chart. Install casing head. Secured well, RD completion unit, well T.A.

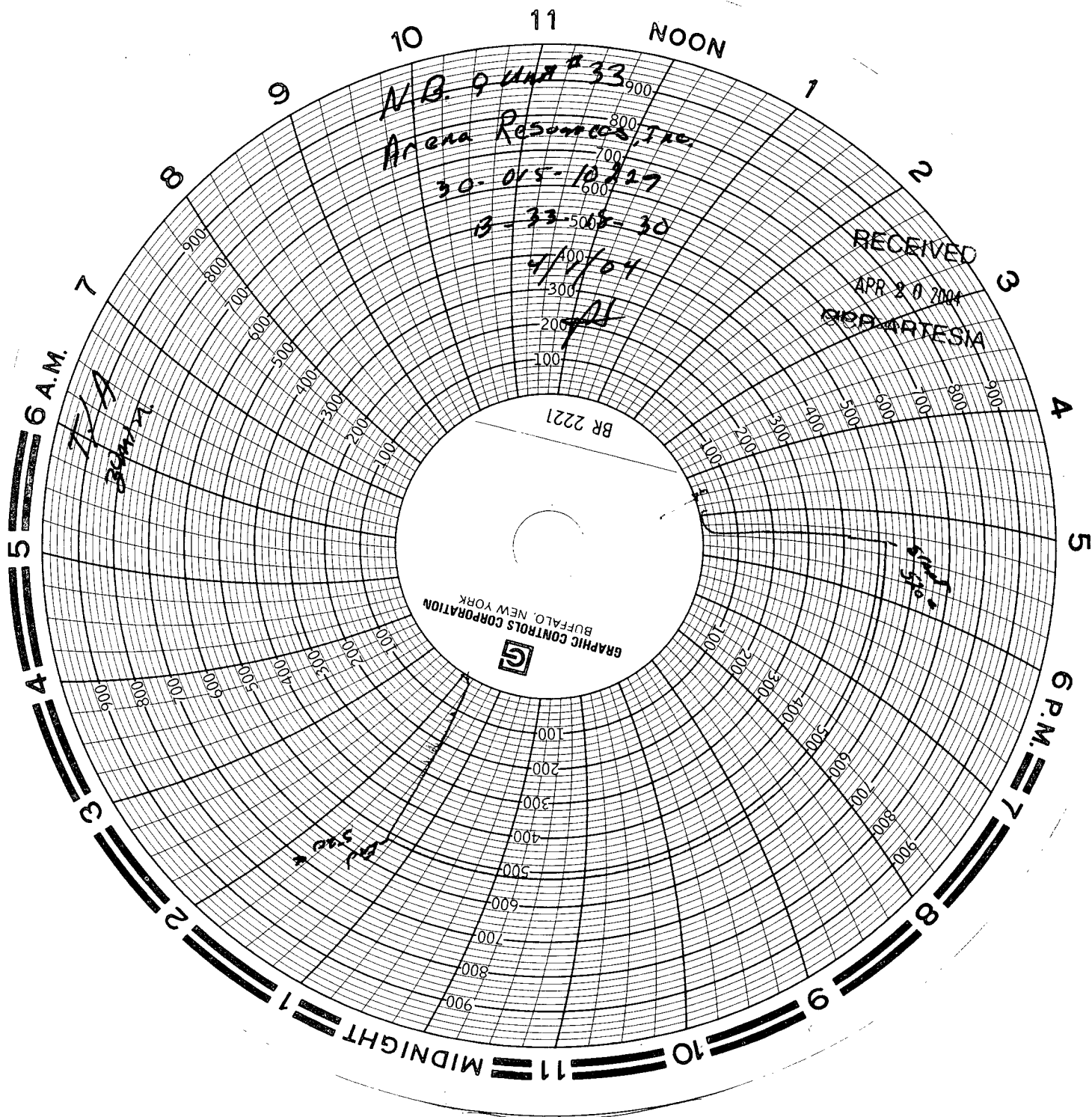
