2. RIH w/RBP to 7400'. Set RBP & POOH w/tbg.
3. RIH w/production tbg, pump and rods. If squeeze is necessary, set cmt retainer @ 7110' & squeeze w/150 sx CI C. Drill out squeeze, retr RBP, & reset @ 7800'. (If zone is productive, rel RBP & reset @ 7800')
5. RIH w/production tbg, pump, & rods. Pump test middle zone. Evaluate for squeezing zone.
6. If squeeze is necessary, set cmt retainer @ 7430' & squeeze w/100 sx CI C. Drill out squeeze, retr RBP, & POOH. (If zone is productive, rel RBP & POOH)
7. RIH w/2 7/8" tbg, TA, pump, & rods. Design TBD based on productive zones.
