1. MIRU a WSU. RU safety trailer as necessary & TOH w/ rods & pump. ND wellhead, NU BOP. TOH w/ tubing.
2. RU WL company & RIH w/ gauge ring & junk basket to +6,750'. POH.
3. RIH w/ 7" CIBP & set at 6,744' dumping 35' cement on top of CIBP. POH.
4. RIH w/ 7" CIBP & set at 6,222' dumping 35' cement on top of CIBP. POH.
5. RIH w/ tubing and circulate hole w/ corrosion inhibited fluid.
6. Shut BOP & test casing to 500 psi for 30 min (10% leak off allowed). Chart test & report.
7. TOH laying down tubing.
8. Call BLM (505-887-6544) 24 hrs prior to conducting MIT. Chart test and report.
9. Clean up location and release equipment.

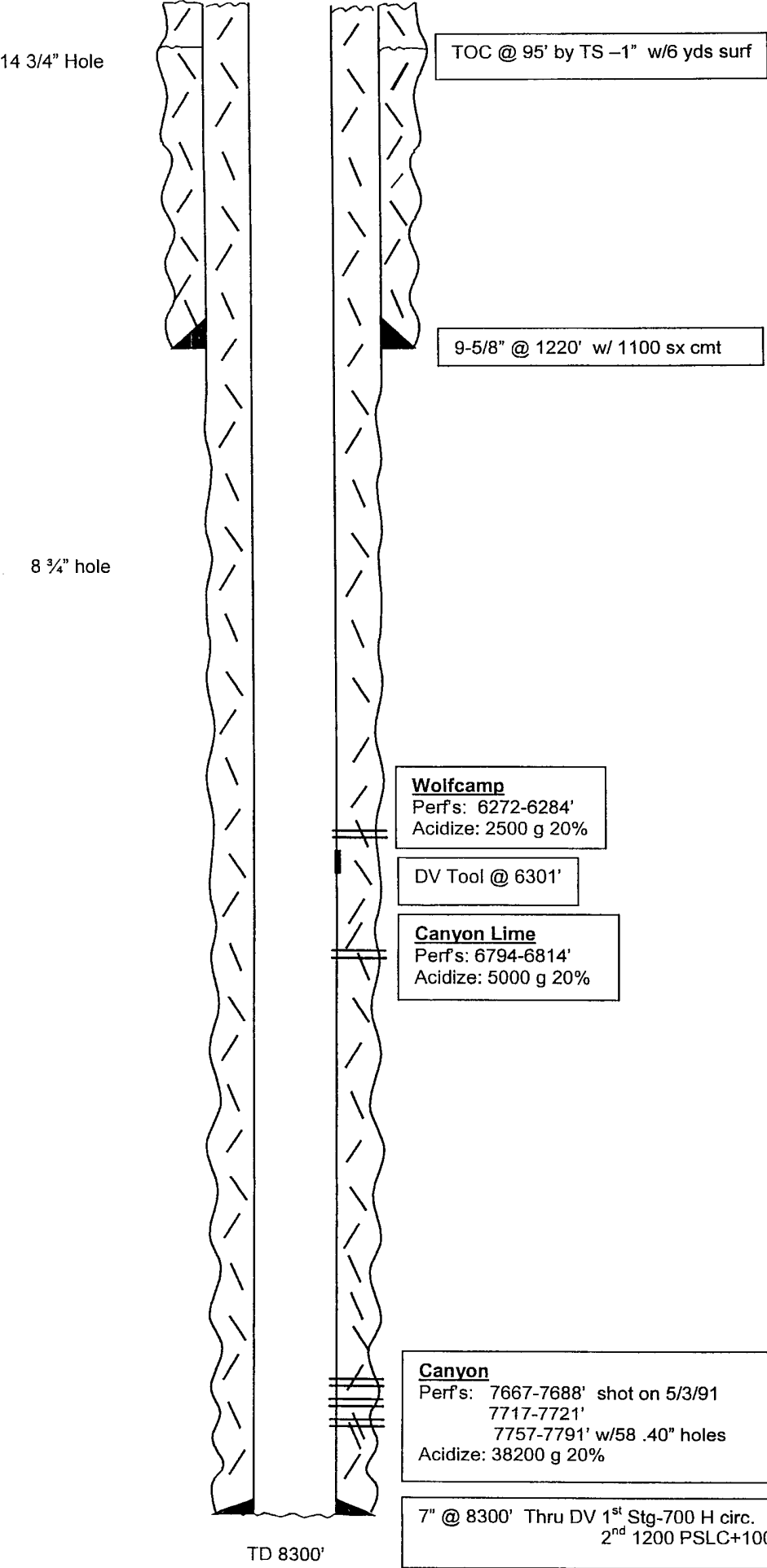

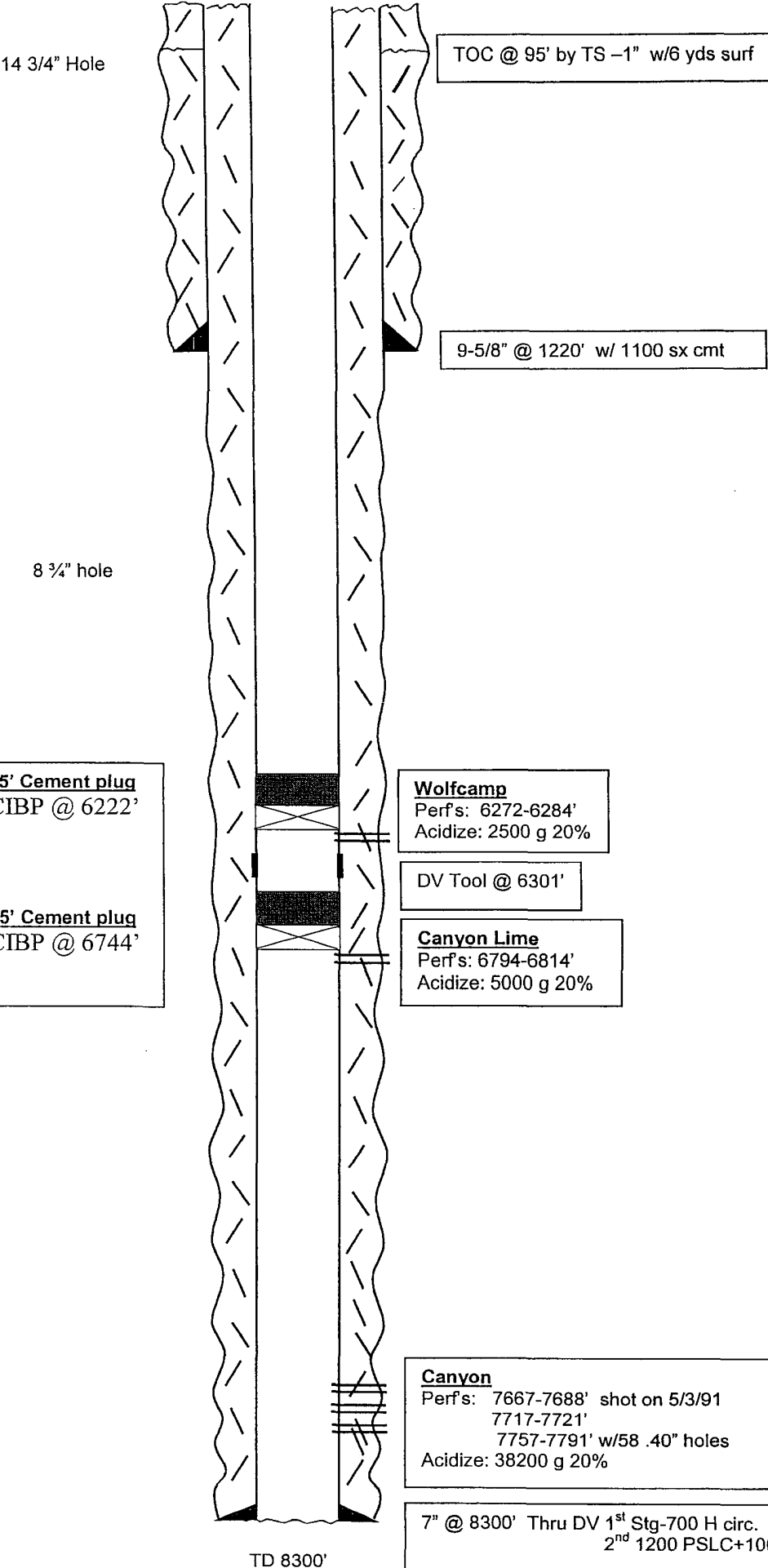
