Gruy is requesting to alter the casing design for its Federal Com 13 # 2 as follows: 17-1/2" 200'  
Set 80' of Conductor pipe, and cement to surface with 12 yds of Ready Mix. Drill 14-3/4" hole to 400'. If we have full returns continue drilling to 2050' or 100' below salt and set 45.5# J-55 10 3/4" casing and cement to surface with 950 sx of Interfill C and Premium Plus. If returns are lost set 400' of J-55 54.5# 13 3/8" casing and cement to surface with 350 sx of Premium Plus. Drill 9 7/8" hole to 10,000' and set 26.40# HCP-110 7 5/8" casing. Cement to surface with 1200 sx of interfill C and Premium Plus. Drill 6 3/4" hole to 13000 TD, and set 17# HCP-110 5 1/2" liner with top at 9700'. Cement in place with 235 sx Super H

\* SET 200' OF J-55 54.5# 13-3/8" CASING AND CEMENT TO SURFACE
