Marathon Oil Company tested the Upper Penn formation in this well and had proposed to produce the well as a dual producer in the Upper Penn and Morrow zones. A "Packer Leakage Test" was performed, as prescribed by the New Mexico Oil Conservation Division. The packer did not hold with the casing valve open. The casing valve was subsequently closed and the well is not producing from the Upper Penn zone. It is producing from the Morrow zone. The packer does not leak as long as the casing valve is closed. If proof is needed that these zones are segregated, please call me at the contact number shown above and I will fax you a copy of the latest gas analysis (performed after the Upper Penn was shut in). If H2S were present in the gas, it would indicate communication, because the Morrow zone in this area does not produce ANY H2S.
