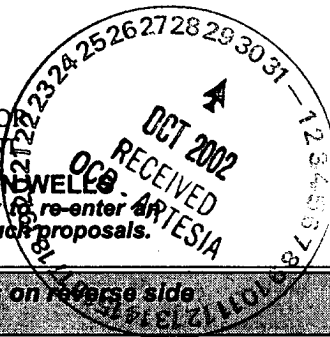

10-16-2002 - Moved in pulling unit and plugging equipment. Installed anchor. Shut down for night.

10-17-2002 - Rigged up pulling unit. Rigged up floor and rod equipment. POOH with rods. Rigged down rod equipment. Nippled down wellhead and nipped up BOP. Rigged up tubing equipment. POOH with tubing. Rigged up wireline. RIH with CIBP and set CIBP at 3100'. POOH and rigged down wireline. RIH with tubing open ended and tagged CIBP. Shut down for night.

10-18-2002 - Circulated hole with plugging mud. Capped CIBP with 35' of Class C Neat cement. POOH with tubing. Rigged up wireline. RIH and perforated 5-1/2" casing at 902'. POOH and rigged down wireline. RIH with tubing and packer. Set packer at 611'. Squeezed with 45 sacks Class C Neat cement. WOC 4 hours. Rigged up wireline. RIH - did not tag. POOH and rigged down wireline. Squeezed with 45 sacks Class C Neat cement. WOC. Shut well in for night.

10-19-21-2002 - Rigged up wireline. RIH - did not tag. POOH and rigged down wireline.



Squeezed with 45 sacks Class C Neat cement. WOC 4 hours. Rigged up wireline. RIH - did not tag. POOH and rigged down wireline. Squeezed with 45 sacks Class C Neat cement. WOC. Shut well in for night.  
10-22-2002 - Rigged up wireline. RIH and tagged cement at 1023'. POOH. Squeezed with 45 sacks Class C Neat cement from 902-802'. WOC 4 hours. Rigged up wireline. RIH and tagged up at 1023'. POOH and rigged down wireline. Squeezed with 45 sacks Class C Neat cement. WOC. Shut well in for night.  
10-23-2002 - Rigged up wireline. RIH and tagged cement at 712'. POOH and rigged down wireline. POOH with packer and tubing. RIH open ended to 700'. Circulated plugging mud from 700' to 450'. Pulled up hole to 450'. Circulated 50 sacks Class C Neat cement from 450' to surface. POOH and rigged down tubing equipment. Nippled down BOP. Topped off well with 5 sacks Class C Neat cement. Rigged down pulling unit. Installed regulation abandonment marker. PLUGGED AND ABANDONED - FINAL REPORT. Plugging completed 10-22-2002.
