Perforate Wolfcamp 4662'-4674' (48), 4696'-4704' (32) and 4744'-4758' (56) for a total of 136 holes. Stimulate as needed. If Wolfcamp production is low, set 5-1/2" composite plug at 4650'. Perforate Abo 4096'-4102' (7), 4140'-4152' (13), 4160'-4170' (11), 4174'-4178' (5), 4212'-4228' (17), 4238'-4250' (13), 4270'-4276' (7) and 4286'-4302' (17) for a total of 90 holes. Stimulate as needed.
