1-31-2003 - Rigged up floor and tubing equipment. POOH with 2-3/8" tubing. Rigged up wireline. RIH with CIBP to 2400' and set CIBP at 2400'. POOH with wireline. RIH and dump bailed 35' of cement on top of CIBP. POOH & rigged down wireline. RIH with tubing. Shut well in for night.  
2-1-3-03 - Circulated hole with plugging mud. Spotted 25 sacks Class C Neat cement at 2400'. POOH with tubing. Shut well in for night.  
2-4-2003 - Rigged up wireline. RIH and perforated 5-1/2" casing at 1360'. POOH & rigged down wireline. RIH with packer and tubing to 1075'. Squeezed with 45 sacks Class C Neat cement. WOC 4 hours. Rigged up wireline. RIH and tagged plug at 1175'. POOH & rigged down wireline. Released packer. POOH with packer and tubing. Shut well in for night.  
2-5-2003 - Rigged up wireline. RIH and perforated 5-1/2" casing at 450'. POOH &

rigged down wireline. RIH with packer and tubing to 128'. Squeezed with 50 sacks Class C Neat cement. WOC 4 hours. RIH and tagged plug at 283'. POOH with packer. Rigged up wireline. RIH and perforated 5-1/2" casing at 60'. POOH & rigged down wireline. Rigged down tubing equipment and floor. Nipped down BOP and 5-1/2" casinghead. Installed 5-1/2" X 2" swedge with valve. Circulated 40 sacks Class C Neat cement down 5-1/2" casing and up to surface of 8-5/8" casing. Rigged down pulling unit and plugging equipment. Installed regulation abandonment marker.
