4. Pick up 4 1/2 x 7" formation PKR. G.I.H. w/65 jts. 4 1/2 csg. PKR set @ 2743'.

5. Rig up Halliburton O.W.S.C.O. pump 325 sx cmt. Circulate to surface 80 sx to the pit.

6. Drill out formation PKR C.O. to T.D. Circulate hole clean. C.O.H.
