Pogo Producing Company request permission to change plans as follows:

Pogo will drill a 12-1/4" hole from 550'-2900' and run 9-5/8" 36# J-55 ST&C casing. Pogo will then drill an 8-1/2" hole to kick-off point and thru build of horizontal lateral. The lateral will be drilled with a 7-7/8" bit where 5-1/2" casing will be run and cemented as per the APD.
