Yates Petroleum Corporation respectfully requests permission to make the following changes to this well:

Change surface casing size from 11 3/4" to a new casing size of 13 3/8". Drill out from the 13 3/8" casing with 12 1/4" hole to a depth of 2,350'. If warranted, 9 5/8" intermediate casing will be run. If 9 5/8" casing is not run, then hole size will be reduced to 8 3/4" and drilled to TD.

It is also requested that permission be given to install a drilling nipple on the 13 3/8" casing while drilling to a depth of 2,350', where either 9 5/8" casing will be run or hole will be reduced to 8 3/4". In either case at 2,350' a BOP will be nipped up and tested.
