10/19/04 – Tested production casing to 1000 psi for 30 mins. Perforate Strawn and Mississippian 6366'-6370' (16), 6376'-6380' (16), 6386'-6406' (80), 6426'-6432' (24) and 6438'-6442' (16) for a total of 152 holes. Acidize with 2000g 7-1/2% IC acid and 225 balls.
10/25/04 – Set CIBP at 6300' with 35' cement. Perforate Wolfcamp 5838'-5848' with 40 holes. Set 4-1/2" 11.6# AS-1 packer with 1.87" on/off tool at 5703'. Acidize with 500g 15% IC HCL.
