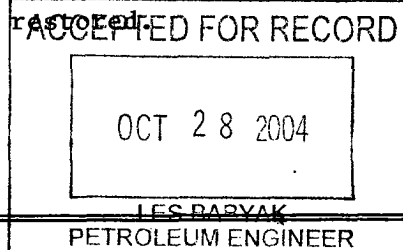
9-28-04 - Move in Rig up pull rods & tubing. RIH w/bit & scraper to 2510'.

9-30-04 - RIH w/tubing & CIBP, set CIBP @1575' displaced to 1331', spot 25 sx cement plug @ 1190' displaced to 946', spotted plug @ 381' to surface. TOOH Pump 10 sx surface plug. Set Dry Hole Marker.

Will notify when equipment is removed & location restored.
