Yates Petroleum Corporation plans to plugback and recompleate this well as follows: Set a CIBP at 7541' with 35' cement on top. Perforate Wolfcamp 6704'-6722' (19). Stimulate as needed. Swab test for evaluation, could turn to production. If not, set a CIBP at 6654' with 35' cement on top. Perforate Bone Springs 5352'-5364' (13) and 5422'-5438' (17). Stimulate as needed. Swab test for evaluation, could turn to production. If not, set a CIBP at 5302' with 35' cement on top. Perforate Yeso 2414'-2420' (7), 2490'-2510' (21), 2516'-2534' (19), 2544'-2550' (7), 2566'-2570' (5), 2586'-2590' (5) and 2634'-2638' (5). Stimulate as needed. Swab test for evalution. Turn well to production.
