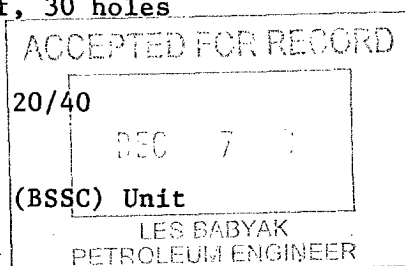

- 5) Put well on production
- 6) Surface commingled production w/ the Tamano (BSSC) Unit
