Followed with 300 sks 35:65:6 "C" with additives. Mixed @ 12.5 #/g w/ 2.04 yd. Tailed with 200 sks Class "C" with 2% CaCl2. Mixed @ 14.8 #/g w/ 1.32 yd. Circ 10 sks to pit. WOC 18 hrs. Drilled out with 12 1/4" bit. At 4:00 pm, tested BOPE & Csg to 800# for 30 minutes as required, all equipment passed. Drilled out with 12 1/4" bit.

11/01/04...TD'ed 12 1/4" hole @ 4778'. Ran 4778' 9 3/8" 40# N80\HCK55 LT&C Csg. Cemented with 1375 sks BJ Lite "C" with additives. Mixed @ 12.5 /g w/ 2.03 yd. Tail with 400 sks Class "C" with 1% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Circ 25 sks to pit. WOC 18 hrs. Nipple up BOPE. At 9:15 pm, test BOPE and 9 3/8" casing to 2800# for 30 minutes as required.
