BJ acidized these perforation w/total 1975 gals 15% HCL acid. Fractured same perforations w/total of 60,000 gals 40# gel, 6000# 100 mesh sand & 35,000 gals heated 20% HCL. Finished w/5,040 gals cool 15% HCL acid. Ran 2. 875" tubing string and 7/8" & 3/4" sucker rods w/down hole pump. Laid a 3 1/2" flowline along existing road to existing Gissler A2 Battery for above ground storage commingling in tanks w/Grayburg & Paddock(Yeso) production from existing Gissler A wells. Installed metering separator @ battery for accurate measurement before entering the battery heater treater. All existing production is allocated based on periodical well individual well test. CVEC installed electricity. We installed surface pumping unit and put well to pumping. Well pumped all load water until January 14,2003.
