Tailed in with 200 sx "C" + 2% S1 (yld 1.32, wt 14.8). Cement circulated to surface. WOC. Tested casing to 1000 psi for 30 min. WOC 23 hrs 15 min. Reduced hole to 11" and resumed drilling.
