Additional Comments: Closure workplan for encapsulation trench. The drilling pit contents will be mixed to stiffen the pit contents. Encapsulation trenches will be excavated and lined with a 12 mil. Synthetic liner on former drilling pit site. Drilling pit contents will then be emplaced into the encapsulation trenches. A 20 mil. Synthetic liner will then be placed over the pit contents with a min. of a 3' over lap of the underlying trench areas. The encapsulation trenches will then backfilled back to grade using a min. of 3' of clean soil and like material. A one call & 48 hour notice will be provide to the Oil Conservation Division before pit closure actions began.

Pit Closure actions to begin by NA. Ending date NA. Mud seed in the proper mixture will be applied.

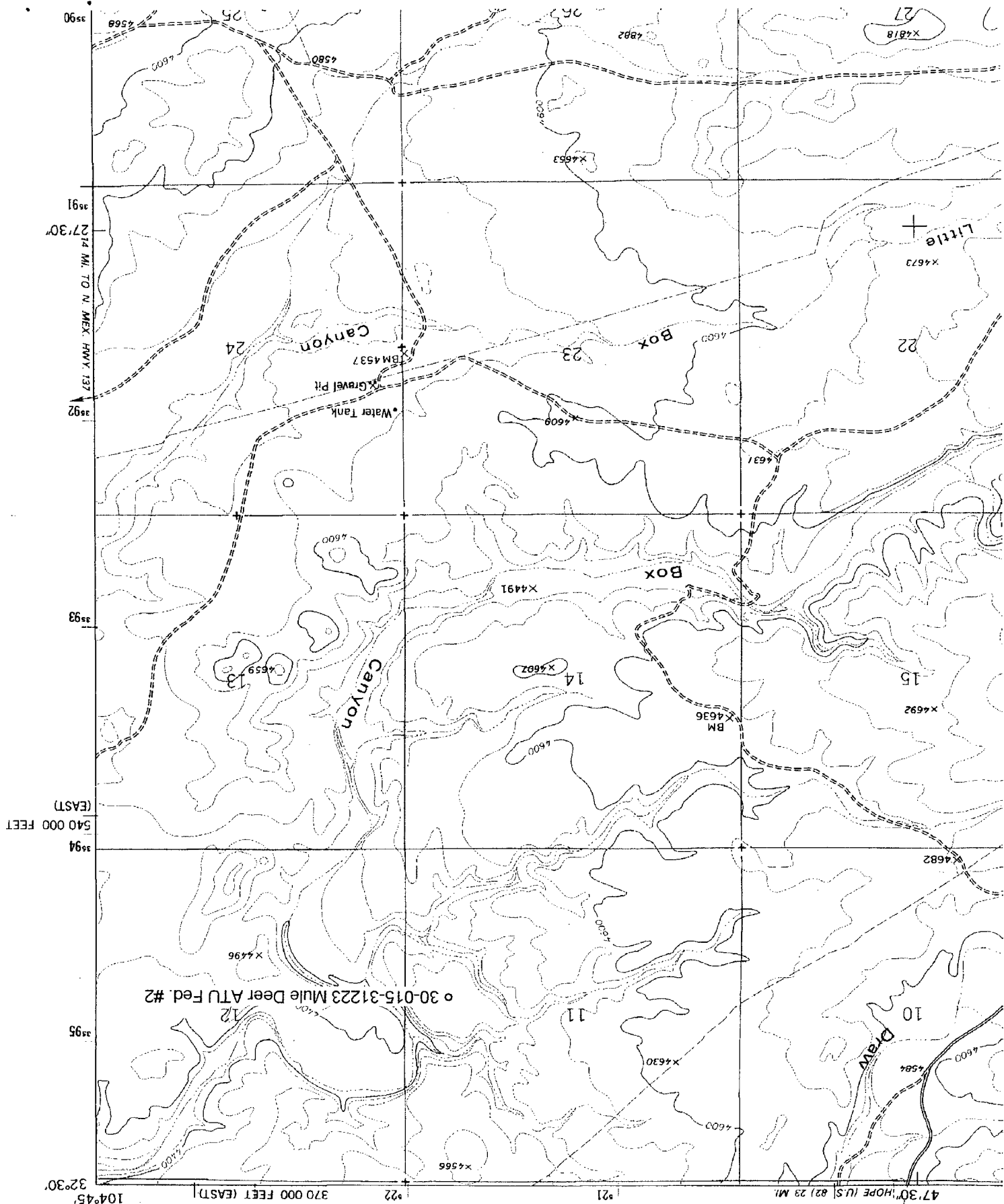
