Pumped 100sx of Thix-Tropic + 400sx of Premium Plus. Did not circulate. Ran 1" to 285' and pumped 150sx of 2% Premium Plus; wait 3 hrs. Pumped 150sx of 2% Premium Plus. No bridging. Wait 4 hrs. Pumped 50sx of Premium Plus 3%; wait 4 hrs. Pumped 50sx Premium Plus 3%. Still no bridging. Called Jim Amos to get approval to dump 10yds of pea gravel. Dumped gravel @ 4PM, 2/05/05. Ran 1" to 84'; pumped 125sx Premium Plus 2%; wait 4hrs. Ran 1" to 25'. Pumped 120sx Premium Plus 2%. Filled up to cellar @ 9:30PM. Wait 18hrs. Nipple up BOP. Test to 1000# for 30 min.
