2/8/05 Latched onto fish. Had 8' sandline on spear. POOH with spear - no fish.

2/21/05 Move in steel pit to plug and abandon well.

2/23/05 Spotted 25 sx cement at 5700'-5551'. RIH with gauge ring to 5550'. RIH with CIBP. Set down at 5405' - stuck.

2/24/05 Plug set. RIH and tagged CIBP at 5405'. Spotted 25 sx cement at 5405'-5256'.

2/25/05 Circulated mud. Spotted 25 sx cement at 1550'-1401'. Spotted 30 sx at 1116'. WOC. RIH and tagged at 928'. Spotted 30 sx cement at 340'-160'.

2/28/05 RIH and tagged at 103'. Cut off wellhead and anchors. Spotted 10 sx cement 60' to surface. Installed dry hole marker. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**
