Cemented with 180 sx "H" + 10% A-10# LCM + 1/4# Celloflake + 1% CaCl (yld 1.52, wt 14.6) and 1000 sx 35:65:6 "C" + 5% salt + 1/4# Celloflake + 5# LCM (yld 2.04, wt 12.5). Tailed in with 200 sx "C" + 1% CaCl (yld 1.34, wt 14.8). Found TOC 755'. Ran 1" cement with 450 sx "C" + 7% CaCl to surface. Tested casing to 1500 psi for 30 mins. WOC 52 hrs 30 mins. Reduced hole and resumed drilling.
