Cemented Stage 2 with 800 sx 35:65:6 "C" + 1% KCL + 5# KCL + 1/4# Celloflake + 5/10% FL-52 (yld 1.97, wt 12.5). Tailed in with 100 sx "H" + 8% A-10 + 8# LCM-1 + .25# Celloflake (yld 1.48, wt 14.6). Tested casing to 1500 psi for 30 min. WOC 46 hrs 30 min. Reduced hole to 6-1/8" and resumed drilling.
