2/18/05 - Set 13-3/8" 48# H-40 ST&C casing at 598'. Cemented with 350 sx Halliburton Lite Premium Plus + 2% CaCl₂ + .25#/sx Flocele (yld 1.89, wt 12.7). Tailed in with 200 sx Premium Plus + 2% CaCl₂ (yld 1.34, wt 14.8). Cement circulated to surface. WOC. Tested casing to 600 psi for 30 min. WOC 19 hrs. Reduced hole to 11" and resumed drilling.

2/21/05 - Set 8-5/8" 32# J-55 8rd ST&C casing at 4139'. Cemented with 800 sx Interfill "C" SBM (yld 2.44, wt 11.9). Tailed in with 200 sx Premium Plus (yld 1.345, wt 14.8). Cement circulated to surface. WOC. Tested casing to 1000 psi for 30 min. WOC 32 hrs. Reduced hole to 7-7/8" and resumed drilling.

2/26/05 - Reached TD 8211' at 7:30 AM. Set 5-1/2" 15.5# & 17# J-55 8rd LT&C casing at 8211'. Float collar at 8168'. Cemented with 1000 sx Premium Plus (yld 1.39, wt 14.5).
