1/26/05 – Resumed drilling at 11:30 AM. Set 13-3/8" 48# H-40 ST&C casing at 388'. Cemented with 440 sx Class "C" + 2% CaCl₂. Cement circulated to surface. Tested casing to 600 psi for 30 min. WOC 22 hrs. Reduced hole to 12-1/4" and resumed drilling.
1/31/05 – Set 9-5/8" 36# J-55 ST&C casing at 1908'. Cemented with 575 sx 35:65:6 "C" + 5% salt + 1/4# Celloflake + 5# LCM-1 (yld 2.05, wt 12.5) and 200 sx "C" + 1% CaCl₂ (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 36 hrs 30 min. Reduced hole to 8-3/4" and resumed drilling.
