The Henshaw 7 Federal #1 is currently completed in the WC Henshaw; Upper Pennsylvanian pool which is no longer producing. Our plan is to plug back and perf the Glorieta zone. Our procedure will be as follows:

1. Set CIBP with 35' of cement above existing perforations (8478-8559')
2. 150' cement plug set at 6400-6550'.
3. CIBP @ 4400' with 35' of cement above.
4. Perforate 4238-4256' with casing gun, 4 SPF.
5. Set packer @ 4150' and acidize with 3000 gallons of 15% NEFE at 5 BPM with 72 ball sealers.
6. Flow back acid and swab test zone; Release packer and clear ball sealers

We will have 9# mud between plugs consisting of 25 ea. 50# sx mud per 100 BBL.
