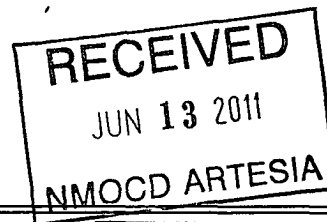

Cement did not circ. Temp survey TOC @ 170', RIH w/ 1" tbg and mix & pump 75 sx class C 2% CaCl, .25% R-38, 14.8 ppg, 1.33 yield. WOC. TIH w/ 1" tbg and tag @ 84', mix & pump 75 sxs class C 2% CaCl, .25% R-38, 14.8 ppg, 1.33 yield. Circ 25 sxs to surface. Cut off 8-5/8 csg. WOC.
