The line is actually located on the edge of an YPC P&A location (Walt Canyon AMA Federal #1, Section 3, T22S-R24E, Latitude: 32.41516; Longitude: 104.48460). The well was shut in and vacuum truck(s) were called to the location. There was no oil (residual from the pipe line) and or produced water recovered.		
Describe Area Affected and Cleanup Action Taken.* An approximate area of 20' X 20' (on pad area) 20' X 100' (off of pad). Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). Based on on-site meeting with the BLM, off pad remediation consisted of Micro Blaze applications (X3) and monitor for approximately 12 months. Depth to Ground Water: >100' (approximately 100', per the ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on impacted soils removed, attached analytical results and BLM remediation work conducted, Yates Petroleum Corporation requests closure.
