3/8/05 Cleaned casing wall from 3000'-3250'. Set 7" CIBP at 7380'.

3/9/05 Tagged CIBP at 7380'. Circulated mud. Spotted 30 sx cement at 7380'-7201'. WOC. Tagged at 7178'. Spotted 36 sx cement at 6733'-6518'. Pulled up hole and loaded casing.

3/10/05 Loaded well to surface with 10# mud. Spotted 36 sx cement at 4146'-3931'. Spotted 36 sx cement at 3184'-2970'. Spotted 50 sx cement at 2487'. WOC. Tagged at 2193'. Spotted 50 sx cement at 696'.

3/11/05 Tagged at 378'. Spotted 27 sx at 165' to surface. Cut off wellhead. Installed dry hole marker. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**

NOTE: No final abandonment sundry will be sent as per Barry Hunt. Battery still active on location.
