The gauge at the wellhead malfunctioned causing a release of mix fluids surrounding the wellhead. A vac truck was immediately called to the location and recovered unknown barrels of fluids.

Describe Area Affected and Cleanup Action Taken.\*

The impacted area surrounding the wellhead and pump jack measures approximately 14' x 20'. All fluids stayed on location. Talon/LPE has already performed site assessment and soil sampling activities. Remediation was completed in accordance with the remediation plan approved by Heather Patterson of NMOCD via email on 05/06/2015.
