Lack of alarms caused a tank to overflow spilling 20 bbls of oil and 160 bbls of produced water onto the ground. A vacuum truck recovered 160 bbls of fluids and the alarm issue was corrected.

The affected area is approximately 75' x 50' on location. Remediation was completed in accordance with a remediation plan approved by Mike Bratcher of NMOCD via email on 04/28/2016 and by Shelly Tucker of the BLM via email on 05/03/2016.
