Upon arrival of the pumper a small hole was discovered on the water leg of the heater treater. Following the discovery of the release, the heater treater was drained and isolated in order to make repairs.

Describe Area Affected and Cleanup Action Taken.*

Affected area- Caliche inside the separation equipment area. The release also impacted a 5 ft. by 25 ft. area of pasture to the east of well pad. Contaminated soil was hauled off and soil samples were taken in order for backfill to be approved. Final remediation was conducted in accordance with NMOCD's Guidelines for Remediation of Spills, Leaks, and Releases.
