Spill caused by a water tank overflow due to high level. Leak has been corrected.

Describe Area Affected and Cleanup Action Taken.*

The release was completely confined to the plastic-lined containment area surrounding the SWD and affected an area inside the containment measuring approximately 2,030 sq. ft. Impacted gravel atop the plastic liner was hand-excavated and hauled to R360 (NMOCD Permit #NM-01-00061) for disposal. Following removal of the gravel, the liner was inspected for holes/tears, and none were discovered. The on-site storage tanks and liner were pressure washed and steam-cleaned, and clean gravel was placed back atop the liner.
