3/10/2020      Cleared location and moved in equipment. Rigged up. Worked pump free and laid down 79 ¾" rods. Dug out cellar. No casing head on the surface casing. Installed BOP and SION

3/11/2020      Laid down 62 joints 2 3/8" tubing. Made gauge ring run to 1850'. Set 5 ½" at 1810'. Picked up workstring and tagged CIBP. Circulated MLF and tested casing to 550#. Casing good. Spot 50 sx Class C cement on top of CIBP. POOH and perforated casing at 499'. Established circulation and pumped cement down 5 ½" casing to perfs at 499' and up the annulus to surface. Took 145 sx. SION

3/12/2020      Rigged down and cut off wellhead. Filled up both strings of casing with 10 sx cement. Installed marker, removed anchors, cleaned the pit and cleared location.
