Circ 263 sks of cmt to the pits. Test BOPE 5000# & Annular to 3500#. Tested standpipe & mud lines to the pumps 5000#. At 9:00 A.M. 10/17/2020, tested csg to 1500# for 30 min, held OK. FIT to 10.5 PPG EMW. Drilled out with 12 1/4".
