Spud well on 7/15/2011. Drill 12-1/4" hole to 390'. Ran 10 jts 8-5/8", 32#, J-55, LTC casing set at 389'. Pumped 20 bbls FW followed by lead 360 sks of HalCem (wt 14.8, yld 1.36). Displace with 23 bbls FW, floats held. Ran temperature survey. TOC @ 32'. Pump 50 sks of Class "C" + additives (wt 14.8, yld 1.36). Circ 29 sks to surface. WOC 27.5 hrs. Tested BOP stack, choke manifold, chokes, kill lines, kelly cocks, and kelly safety vavles to 2000 psi high & 250 psi low. Tested annular to 1000 psi. Tested casing to 1500 psi - test good. Drilled 7-7/8" hole to 3,200'. Ran 78 jts of 5-1/2", 17#, J-55, LT&C casing set at 3,199'. Pumped 20 bbls gel followed by lead 585 sks Econocem + additives (wt 12.9, yld 1.87) followed by tail 135 sks Versacem + additives (wt 14.2, yld 1.32). Displace with 72 bbls FW. Bumped plug with 1650 psi. Floats held. Circ 76 sks of cement to surface. WOC 11.5 hrs. Installed tubing head and tested to 2000 psi - tested good. Rig released on 7/24/2011.
