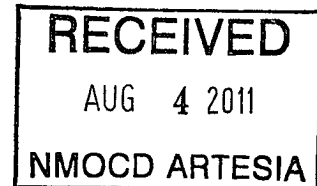
Ran temperature survey, TOC at 63'. Top out w/ 258 sx Class C. Cement to surface. WOC 26 hrs.
