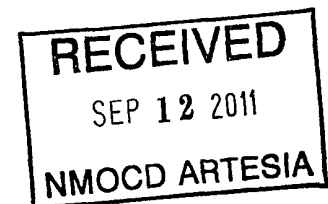

BOPCO, L.P. requests approval of the below revised re-entry procedure as discussed with Wesley Ingram (BLM) on 5/5/11. Upon uncovering the previously abandoned wellbore, BOPCO, L.P. found the 13-3/8" intermediate casing off centered and cemented to surface inside the 20" surface casing. Because of the misalignment, BOPCO, L.P. proposes to nipple up on the 13-3/8" casing with a 13-5/8", 5000 psi SOW instead of the 20" casing as previously approved.

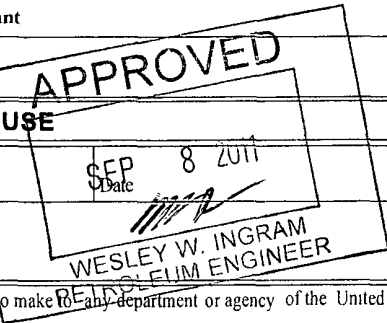
