1. **EXISTING ROADS**



- a. The proposed 292.8 feet of road will intersect an existing two track road. This two-track road used to be an Eddy County road (Rock Dove Road), but the county no longer maintains it. Chesapeake plans to upgrade this two-track road starting from the proposed road northeast to Buck Jackson County Road. The length of two-track to be upgraded is approximately 4,000 feet. The two-track road will be upgraded to have a 16 feet wide driving surface with the maximum disturbance of 30 feet width for construction. The driving surface grade and ditch design will be the same as the proposed road as shown on Exhibit H-2. Six inches of surfacing material will be compacted for the driving surface.
- b. One turnout will be constructed. See Exhibit H-1.
- c. Driving directions are from the junction of McDonald and Twin Wells, go Southwest 1.3 miles to lease road, on lease road go South 0.5 miles to lease road, on lease road go west to PLU 111 pad and proposed lease road. From Loving North on Carter Road to State Hwy 31 to State hwy 128. East on 128 to Twin Wells Road. South on Twin Wells Road to Buck Jackson. From the junction of Buck Thorn and Buck Jackson, Go Westerly turning Northerly for 3.1 Miles to lease Road (old Rock Daisy), Go Southeast on Lease Road For 0.8 Miles to Proposed Lease Road.
- d. See Exhibits A-1 to A-5.

2. NEW OR RECONSTRUCTED ACCESS ROADS

a. The proposed new road will be 292.8' in length. The maximum width of the driving surface will be 14 feet. The road will be crowned and ditched with a 2% slope from tip of the crown to the edge of the driving surface. The ditches will be 1 foot deep with 3:1 slopes. The driving surface will be made of 6" rolled and compacted caliche. Right-of-Way will be 20 ft in width.

- b. Surface disturbance and vehicular travel will be limited to the approved location and approved access route. Any additional area needed will be approved in advance.
- c. See Exhibits H-1 to H-2.

3. <u>LOCATION OF EXISTING WELLS WITHIN A 1-MILE RADIUS OF THE PROPOSED LOCATION</u> – see Exhibit B.

4. LOCATION OF PRODUCTION FACILITIES

- a. It is anticipated that production facilities will be located on the well pad and oil to be sold at the wellhead and/or tank battery.
- b. Initially this will be a standalone battery but we plan to build it with capability to handle offsite wells.
- c. Pipeline will come from SUG.
- d. Oil and gas measurement will be installed on this well location.
- e. See Exhibit C.

5. LOCATION AND TYPES OF WATER SUPPLY

- a. Water will be obtained from a private water source.
- b. Chesapeake staked a 250' x 360' fresh water pond east of the proposed location.
- c. Water to be hauled in.
- d. The pond will be 10' deep top of berm to bottom.
- e. A temporary 10" aluminum transfer line will run approx. 4800' from the pond to the location.
- f. See Exhibit E-1 to E-3.

6. CONSTRUCTION MATERIALS

No construction materials will be used from Section 14-25S-30E. All material (i.e. shale) will be acquired from private or commercial sources.

METHODS FOR HANDLING WASTE DISPOSAL

- a. A closed system will be utilized consisting of above ground steel tanks.
- b. All wastes accumulated during drilling operations will be contained in a portable trash cage and removed from location and deposited in a state approved facility.

8. ANCILLARY FACILITIES None

9. WELLSITE LAYOUT

- a. The proposed site layout will be a 320' x 300' pad.
- b. The plat is attached showing the Patterson Rig #62 orientation and equipment location.

10. PLANS FOR RECLAMATION OF THE SURFACE

Interim reclamation will be delayed to allow another well to be drilled on the proposed well pad, alternate well location unknown at this time.

Final Reclamation Procedure: Upon final abandonment of the well, caliche material from the well pad and access road will be removed and utilized to recontour to a final contour that blends with the surrounding topography as much as possible. Any caliche material not used will be utilized to repair roads within the lease. Topsoil will be distributed over the reclamation area and cross ripped to control erosion, the site will be seeded with an approved BLM mixture.


