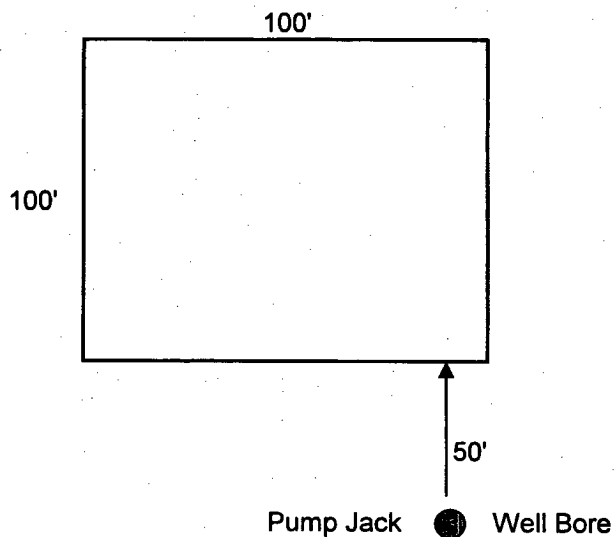

Transfer cuttings to one side of pit. Dig deep bury pit in the cleaned side of pit. Line pit with 12 mil plastic. Add material to cuttings to stiffen. Transfer stiffened cuttings to lines pit leaving a mound in center for drainage. Cap with 20 mil liner. Cover with three feet of cover material.
