

- 1. One 250 bbl steel pit used to circulate fluids and solids into via flowline connected to wellhead.
- 2. Vacuum trucks used to haul off circulating fluids.
- 3. Backhoe used for removal of solid waste into haul off bins.
- 4. Haul off disposal bin used to haul solid waste to disposal facility.
- 5. Closure Plan: Haul all fluids and solid waste to disposal facility and remove steel pit.
