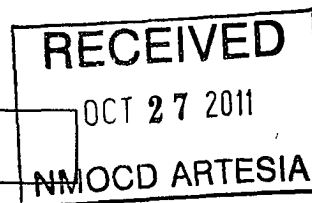

LINN respectfully requests an extension for the reactivation of this well. LINN is in the process of seeking the appropriate regulatory approvals that are needed to convert this well to a Seven Rivers/Grayburg injector. Currently, this well is only injecting into the Grayburg Jackson formation; however, LINN proposes to add the Seven Rivers zone as an injection interval. LINN will salvage this wellbore by installing and cementing 4" flush joint casing from surface to the top of the Seven Rivers zone. LINN will then perforate the Seven Rivers and inject into the Seven Rivers/Grayburg Jackson (current injection interval). Since this lease is not unitized, LINN will be filing the appropriate paperwork to ensure that these zones can be commingled; therefore, LINN respectfully requests an extension that is sufficient to allow for LINN to secure confirmation that the Seven Rivers and Grayburg Jackson zones can be commingled.
